Ecology is a leading international journal in the field of ecology. It contains articles and essays that report and interpret the results of original scientific research in basic and applied ecology. *Ecology* is widely recognized as an essential tool for ecologists; resource planners and managers; and conservationists and professionals in botany, zoology, entomology, limnology, oceanography, forestry, fisheries, range management, agronomy, and crop protection. *Ecology* was established in 1920.

Ecological Applications publishes ecological research and discussion papers of specific relevance to environmental problem-solving, policy, and management. The audience includes basic and applied scientists who deal with global climate change and biogeochemistry, conservation biology, ecotoxicology and pollution ecology, fishery and wildlife ecology, forestry, agroecosystems, range management, soils, hydrology and groundwater, landscape ecology, and epidemiology. *Ecological Applications* began publication in 1991.

Ecological Monographs publishes complex, multi-faceted studies that demand greater length than those published in *Ecology* or *Ecological Applications*. These are not merely long papers, but must tell a truly complicated scientific story with multiple components. *Ecological Monographs* began publication in 1931.

Frontiers in Ecology and the Environment is international in scope and interdisciplinary in approach. *Frontiers* focuses on current ecological issues and environmental changes. It contains peer-reviewed, synthetic review articles, and short research communications on all aspect of ecology, the environment, and related disciplines.

Ecosphere is an online-only, open-access publication with a scope as broad as the science of ecology itself. The journal publishes submissions from all sub-disciplines of ecological science, including theoretical, empirical, and applied ecology. *Ecosphere* began online publication in 2010.

ESA Bulletin is an online publication only and contains announcements and programs of meetings of the Society and related organizations, information about awards and future activities, reports on financial matters, and other items of current interest to ecologists. It is more of an information publication than the journals.

IMPORTANT INSTRUCTIONS FOR SUBSCRIPTION AGENTS

AGENCY ORDERING:

1. **Please place orders by “client,” not by journal.** If a client is renewing or subscribing to more than one journal, please list all of the journals at the same time.
2. **No journal subscriptions will be accepted for the current year (2015) after 9/15/2015. These journals must be purchased as back issues.** Order forms can be obtained online or by contacting ESA at: 1990 M St, NW, Suite 700, Washington, DC 20036. 3. **AGENCY REMITTANCE ADVICE** – Appropriate remittances should accompany checks made payable in US Dollars only to: The Ecological Society of America, PO Box 96121, Washington, DC 20090-6121. Foreign orders should use drafts on US banks or US postal money orders. Visa or MasterCard orders may be faxed to: (202) 833-8775. A copy of the renewal form must accompany the check to guarantee proper posting to the subscriber's account.
4. **SUBSCRIBER ID NUMBERS** – The subscriber identification number is printed on the renewal notice. This ID number must be referenced on all orders, correspondence, checks, purchase orders, and claims. Correspondence and claims sent to ESA without the subscriber ID number will experience delays in processing. 5. **CLAIMS** – Claims from US subscribers will be honored if received within five (5) months of the issue mail date. Claims from non-US subscribers will be honored if received within ten (10) months of the issue mail date.
